

Trumbull County 4-H Honor Club Application

Due 1st Monday in October Each Year

A 4-H Honor Club encompasses the core values of 4-H as stated in the motto, pledge, and the eight keys of positive youth development. These values are achieved and implemented in multiple ways by a club's meetings, project work, club activities, overall participation and passion for 4-H. Honor Club recognition is meant to challenge clubs to set goals, work together to achieve those goals and grow as an individual club.

Honor Club Requirements and Guidelines

All Trumbull County 4-H clubs are eligible to apply for Honor Club recognition. There is no limit as to the number of clubs that may be recognized. Honor Club recognition is intended for clubs that have achieved the basic club activity requirements and want to set goals to go beyond their best and make it better.

Clubs may track participation and activities completed between October 1st and September 30th of each year. Applications must be submitted to the Extension office by the first Monday in October in order to be considered.

In 2022, there will be three levels of Honor Club Recognition:

Gold Level- 325 pts and above

Silver Level- 275 points- 324 pts

Bronze Level- 225 pts-274 pts

How do I obtain an application?

1. Honor club applications are distributed with the Fall Edition of the Leader. Extra copies are also available in the office.
2. Advisors and members work together to decide if they want to apply for Honor Club recognition. If yes, the club decides on the goals they want to set to meet the requirements.
3. Designated advisors, members, and parents work together to track progress and document activities.
4. Club submits Honor Club application (one per club) and **required attachments** to Extension office by **the First Monday of October** for review by the Trumbull County 4-H Advisory Committee. ***Application must be accompanied by additional notes sheet. Sheet can be used to explain or share details about participation in activities. Note: The awards' committee does not have access to the secretary book when honor club applications are reviewed. Therefore, you will need to submit a copy of the minutes from your meetings as documentation with your application in order for your application to be considered. Thank you.**

What is required of a Trumbull County Honor Club?

Honor Club applicants must first complete all basic club organization requirements.

1. Must be a club in good standing.
2. Complete all enrollment requirements and submit to the Extension Office by **April 1st** by 4:30pm.
3. Elect officers and conduct a minimum of six business meetings.
4. Complete secretary and treasurer officer books submitted to the Extension Office by first Monday in October, 4:30pm. Officer Books must be completed by 4-H members. Books completed by advisors and incomplete books will result in ineligibility.
5. Submit annual financial summary by January 31st of application year.
6. Plan and implement at least one family meeting and one educational program.
7. Participate with a 4-H Booth in the block building or barn.
8. All club volunteers have completed their volunteer developmental trainings and are in good standing.
