Attend 4-Station Judging during Animal Project Judging on Tuesday , June 4 , 2024 from 6:00 8:00 p.m. Make-up date is Saturday, June 22, 2024 beginning at 9:00 am at the Trumbull County Fairgrounds. All make-ups must pre-register via Qualtrics. A hands-on portion of 4-Station Judging will also be held during fair on Sunday, July 7 th from 6:00-8:00 PM -OR-Monday, July 8 th from 12:00-2:00 pm.
If interested in PAS/Ohio State Fair, there will be two dates for qualification at the Trumbull County Fairgrounds: 1. June 1, 2024 2. June 23, 2024 . Shows begin at 9:00 AM. You may attend another county, however there is a form you must complete in order to do so. O You must declare your PAS horse by June 1, 2024. PAS class selection must be turned in to the PAS Committee by May 25 th .

Special Notes:

ALL riders MUST wear a certified safety helmet during ANY 4-H event OR ANY event on the Trumbull County Fairgrounds while mounted.

<u>ALL first-year members</u> must attend an Equine Safety Meeting. First year members must also sign the Safety and Ethics Training Form available in the Horses, Safety and You Project Book (191R).

Members who are leasing horses must fill out a lease form. One copy remains with 4-H member (leasee), one copy with owner of horse and one copy with 4-H Educator. Lease forms can be found on our county website: www.trumbull.osu.edu >> 4-H Youth Development >> Trumbull County Fair >> Trumbull County Jr. Fair Forms. According to state rules (under ownership), a horse may not be leased by more than one 4-H member/rider*** Reference Page 4 of Uniform Rules for 4-H Horse Shows, Ownership #1.

Coggins Test for PAS Exhibitors: Exhibitors must provide a copy of their equine's current negative Coggins test (dated on or after January 1st of the current calendar year) to their county 4-H educator (or representative designated by the county 4-H educator) to be submitted with their PAS verification form by the date specified by their county. Counties may require that youth submit a copy of their equine's current negative Coggins test (dated on or after 1/1/2024) with their PAS entry form.

Each equine member must attend three equine-related education opportunities approved by their advisor. Forms are due by October 1st.

Project Information:

- Members <u>must</u> complete project judging/skillathon for their respective project in order to exhibit at the fair and receive 4-H credit for the year.
- Horse Person Contest: Registrations can be found on county website & in county horse booklet. Registrations due Wednesday, May 1st by 4:00 PM. Activity resumes, impromptu essay and written exam will be handed in and given on Monday, June 3rd from 5:00-7:00 PM at the OSUE Office. Riding portion will be held Monday, July 8th at 6:00 PM at the Trumbull County Fair. Contact advisors: Elaine Brown, Priscilla Alfonsi, Emily Woodford & Jenny Coelho.

Fair Information:

- Horses must arrive before 12:00 pm on Monday, July 8, 2024 at the Trumbull County Fair.
 - Reminder: All horses must pass veterinary inspection by designated fair veterinarian. In the case a horse is sent home due to low body condition or health reasons, a 4-H member may NOT substitute another horse for any reason or ride another member's project (including siblings) during the Trumbull County Fair. The only horse(s) a member is permitted to ride at the Trumbull County Fair is that which was registered under the member's name.
