Exhibitors are limited to 2 pens of each poultry species and a maximum of 4 TOTAL pens per Livestock Sales. Chicken Pens will consist of 3 birds per pen, all other species are limited to 1 bird per pen.

I/We understand that I/we must appropriately care for all registered animals during the fair week. Caring for registered animals includes but is not limited to the following items:

1. Cleaning in, around and underneath each registered animal's cage before 10am daily (and before the start of show days) and again by 6pm daily.
2. Making sure each registered animal is properly fed and watered throughout the day.
3. Cleaning each registered animal's cage prior to leaving the fairgrounds at the released time of 7pm the last day of fair.
4. All Turkey and Goose cages must be furnished by the exhibitor, pens must be 3'x3'x3'.
